

Energy Management Information Systems (EMIS)

Access up to \$250,000 in funding for your industrial or manufacturing facility

Energy Management Information Systems (EMIS) is one of four activities in Emissions Reduction Alberta's (ERA) \$50 million Strategic Energy Management for Industry (SEMI) program.

SEMI covers up to 50% of eligible project costs for for-profit organizations and up to 100% of eligible project costs for not-for-profits and Indigenous organizations.

The EMIS activity offers up to \$50,000 for facilities consuming under 400,000 GJ annually, and up to \$250,000 for those consuming more, to implement recognized energy management systems (EnMS), including ISO 50001-compliant and ISO 50001-certified systems.

OUR APPROACH

ERA's service provider, Enerva Energy Solutions Inc., will evaluate your current EMIS setup through a Facility Readiness Assessment (FRA). Based on the findings, you may:

- ▶ Receive a final report that summarizes opportunities for an EMIS
- ▶ Choose to work with internal staff or an eligible contractor to upgrade or install the EMIS

Organizations with an EMIS save an average of 20% more energy than those without. An EMIS includes hardware and software components that support:

- ▶ Data collection and monitoring: Using sensors, meters, and software to gather real-time data on energy consumption and production levels
- ▶ Analysis and optimization: Analyzing data to identify inefficiencies, track energy consumption patterns, and optimize processes
- ▶ Reporting and decision making: Providing insights into energy use, which helps in making informed decisions, detecting anomalies, and implementing corrective actions promptly

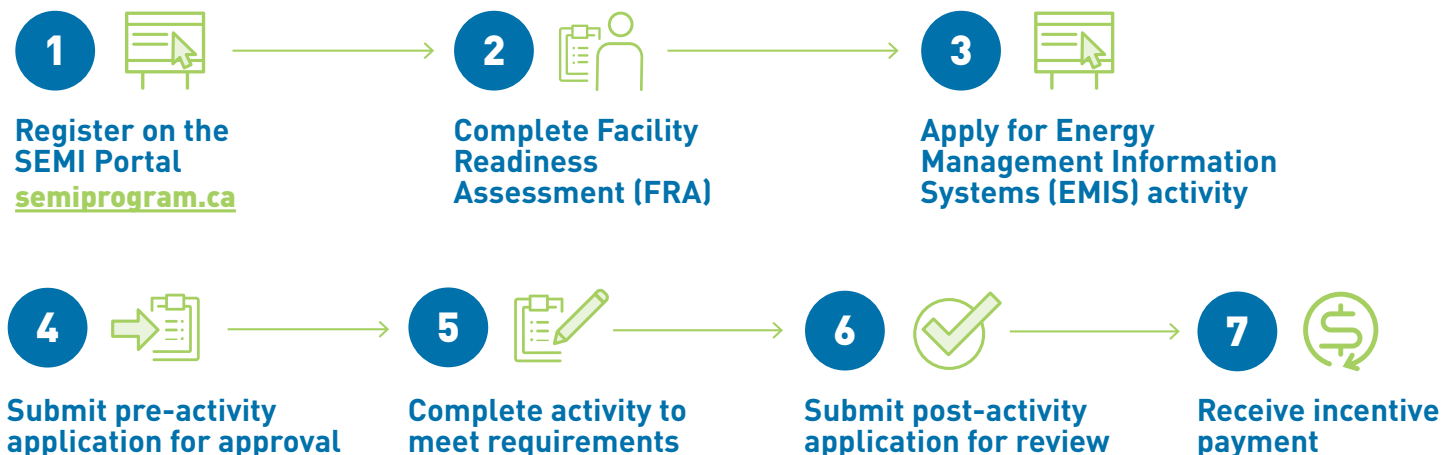
